



## Resident Management System Clinical Schedules and Quick Tracker

This option schedules clinical visits (i.e. attending physician, PA, nurse clinician, OT, PT, and ST visits, etc.) and other events (ex. Monthly Summaries) which are cyclical.

Schedules may be set up for any time frame. For recurring events that take place on a regular basis, the system stores the day(s) of the week, the cycle, and the clinician's name and discipline. Once residents are seen, they are automatically scheduled for the next cycle. One-time or unscheduled events or visits are also easily tracked, stored, and maintained for reporting.

Tracking of attending clinician and therapy visits includes HCPC Codes and ICD-9 codes which are then utilized by Billing for Medicare A and B claims. Therapy reports are available by HCPCS for individual and facility.

### General Features:

- Schedule physician and clinician visits, both cyclical and single visit.
- Provides schedules and tracking for occupational therapy, physical therapy, speech therapy and respiratory therapy. Tracks HCPCS, units, minutes, dates of service, clinician providers and relevant ICD-9 codes.
- Quick Tracker and touch screen data input (also available with keyboard and mouse entry) makes data entry so easy the therapists can enter it in real time immediately after treatment has been completed.
- When residents are scheduled or seen they are simply checked off on a convenient "pop-up" screen. Cancellations and associated reasons are also tracked.
- Reports are available between any two dates and provide information for PRI assessments and MDS assessments on restorative therapy units, minutes, and visits.
- Therapy productivity and monthly summary reports available.
- Interactive with Billing module. Therapy information is moved to the A/R and to the UB-04 for both the Medicare A and Medicare B claims.
- Tracks HCPCS data for 1500 physician's billing.
